Vacancies of the above post reported exclusively for Scheduled Tribes will also be advised from this list and only in the absence of Scheduled Tribe candidates in this list, fresh notification for 'Scheduled Tribes' will be issued for such vacancies.

> Only Candidates born between 02.01.1981 and 01.01.2003 (both dates included) are eligible to apply for this post. No other age relaxation will be allowed.

Note:- 1 In the absence of qualified candidates within the age limit the upper age limit shall be relaxed up to 50 years. But, in no case, the maximum age limit shall exceed 50 (Fifty) years.

2 Age relaxation upto 5 years in maximum age limit is admissible to those who are employed in the Drugs Control Department for appointment to the post of Technical Assistant.

Qualifications:

Degree in Science with Chemistry as main subject with not less than 60% marks from a recognized University.

Note:- 1 An in-service training of three months will be given to the direct recruitees during the period of probation after appointment to the post.

- 2 The Degrees/Diplomas awarded by UGC approved Universities or Institutions established through an Act passed by the Parliament/State Legislative Assembly in accordance with the conditions laid down in G.O(M.S) No. 526/PD dated 17.07.1965 are acceptable for appointment in Government Services.
- 3 Rule 10(a)(ii) of part II of KS&SSR is applicable.
- 4 In addition to the qualifications prescribed in this notification, the qualifications declared by the Government to be equivalent to the prescribed educational qualifications through executive orders or standing orders, and higher qualifications with the prescribed qualifications as the basic qualifications shall be accepted. The Government orders regarding equivalent qualification/higher qualification shall be produced at the time called by the Commission.
- 5 If the caste is wrongly mentioned in the SSLC book, the candidate should claim the original caste in the application and should produce the Community Certificate issued by the revenue authority concerned and the Gazette Notification to prove the same at the time of certificate verification.

Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion of the photograph uploaded. Candidates who create their profile from 01/01/2022 should upload their photograph taken within the period of six months. The uploaded photograph having all the required specifications shall be valid for 10 years from the date of taking of photographs. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of personal information and the secrecy of password. Prior to the final submission of the application on the profile, candidates must ensure correctness of the information incorporated in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisionally accepted and cannot be deleted or altered after submission. Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. correspondences with the Commission, regarding the application should be accompanied with the print out of the application. The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original documents to prove qualification, experience, age, community etc. have to be produced as and when called for. Candidates are directed to submit the applications in accordance with the general conditions included as part II of the the Gazette Notification. Applications submitted in contravention of general conditions shall be rejected.
