Note :- (3) **22 (Twenty Two)** candidates who have secured top most marks in the OMR examination are included in the Main List of this Short List. The mark secured by the last candidate in the Main List is **50.33 (Fifty (point) thirty three)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes."

Note :- (4) Candidates included in the Short List should present in person for OT Verification and Interview with all original documents . Date, time and venue will be intimated in due course through profile message and SMS.

Note :- (5) According to the existing procedure revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) SC/ST Candidates included in the Short List are required to produce Community certificate (in Form III digitally signed) issued by the concerned Revenue authority . Candidates belonging to other reservation groups should produce Non Creamy layer certificate and those who claimed EWS should produce relevant certificate issued by Village officer at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on 12-06-2023 will be issued to those candidates who apply for the same remitting the prescribed fee after approval of the Ranked List. Answer scripts of no candidates are invalidated as per Notification No : ER11(2)4009/2023/EW Dated 01/11/2023.
