Applications are invited online only by 'One Time Registration' from qualified candidates for the post mentioned below. Candidates shall apply only through the online facility provided in the website of Kerala Public Service Commission viz, [www.keralapsc.gov.in](http://www.keralapsc.gov.in). Candidates who have already registered can apply through their profile.

1. **Department** : **Kerala Police**
2. **Name of Post** : **Woman Police Constable(Trainee) (Woman Police Battalion)**

Note: Differently abled candidates and Male candidates are not eligible to apply in response to this notification.

3. **Scale of Pay** : **₹ 31,100-66,800/-**
4. **Number of vacancies** : **Anticipated Vacancies**

The recruitment to the post of Woman Police Constable will only be to the Woman Police Battalion and the vacancies occurring in the district will be filled up by transferring the officers on the basis of Advice/Rank Seniority. (GO(Rt)No. 1484/2017/Home dated 05.06.2017).

**Note:** The Ranked list published shall cease to be in force after one year from the date of finalization of the ranked list. Candidates will be advised from the said list against the vacancies reported after the validity period of previous ranked list and that may be reported to the Commission during the period of currency of the ranked list as per this category.

5. **Method of appointment** : **Direct Recruitment (Statewide)**
6. **Age limit** : **18-26.** Candidates born between 02.01.1997 and 01.01.2005 (both dates included) only are eligible to apply for this post.

**Note:-**

Maximum age limit shall be relaxed upto 29 years for candidates belonging to other backward communities and 31 years for SC/ST candidates. [For other conditions regarding age relaxation, please see para 2(i) of the General Conditions.] Other conditions regarding age relaxation in Para (2) of the General Conditions are not applicable to this selection.

7. **Qualification:-**

(a) **Educational Qualifications:** Pass in Higher Secondary (Plus Two) Examination or its equivalent

**Note:** i) In the case of SC and ST candidates who have failed in the Higher Secondary (Plus Two) examination shall also be considered if sufficient number of qualified candidates not available to fill up the Quota reserved for SC and ST.  
ii) Rule 10 (a) (ii) of Part II of the KS&SSR is applicable.

(iii) *In addition to the qualification specified in the Notification, the qualification declared by Government through executive orders or standing orders, as equivalent to the prescribed educational qualification and the higher qualifications of the notified*

and prescribed basic qualifications shall be accepted. The Government Order regarding the equivalent qualification/higher qualification shall be produced as and when called for by the Commission.

**(b) Physical Qualifications:**

- (i) Height : A minimum of 157 cm.

**Note:**

Minimum Height measurement shall be 150 cm for candidates belonging to Scheduled Caste and Scheduled Tribe communities.

- (ii) Eye Sight: Must be certified to possess the visual standards specified below without glasses.

- Note:-**
- (i) Each eye must have a full field of vision.
- (ii) Colour blindness, squint or any morbid conditions of the eye or lids of either eyes shall be a disqualification.
- (iii) Must be free from apparent physical defects like knock-knee, flat foot, Varicose vein, bow legs, deformed limbs, irregular and protruding tooth, defective speech and hearing.

- (c)** Must qualify in any five events out of eight events specified below of the National Physical Efficiency, One Star Standard Test.

**Note: -**

Physical measurement of candidates will be taken at the time of physical efficiency test and those who do not possess the prescribed physical measurement will not be admitted for the physical efficiency test. If accidents or injuries happen to a candidate while participating in the physical efficiency test, she will not be given no further chance to participate in the test.

The candidates should produce at the time of physical efficiency test, a Medical Certificate in original in the form of prescribed here under, certifying to their physical fitness and eye sight without glasses. The Medical Certificate should be one obtained from a Medical Officer under the Government not below the rank of an Assistant Surgeon/ Junior Consultant.

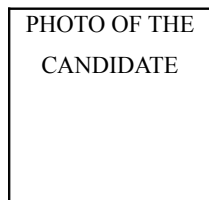

**Note:**

Details regarding standards of vision should be clearly stated in the Certificate as given above and vague statement such as Vision Normal/average/good will not be accepted. Specification for each eye should be stated separately. If the specifications are not as indicated above, the officer issuing the Certificate should certify whether the candidate has got better standards of vision or worse standards of vision as the case may be, otherwise the Certificate will not be accepted.

**8. Mode of submitting applications:-**

(a) Candidates shall register as per ONE TIME REGISTRATION system on the Official Website of Kerala Public Service Commission '[www.keralapsc.gov](http://www.keralapsc.gov).' for applying for the post. Candidates who have registered shall apply by logging on to their profile using their User-ID and Password. Candidates shall click on the 'Apply Now' button of the respective posts in the Notification Link for applying for a post. The Photograph uploaded in the profile of the candidate who have already registered should be taken after 31.12.2013. Candidates who are creating new profile from 01.01.2023 onwards must upload photograph which is taken within six months. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application. Applications submitted not in accordance with the conditions of the notification will be summarily rejected if non compliance with the notification is found in due course of processing. Original documents to prove qualification , experience , community, age etc., have to be produced as and when called for.

(b) If Written Test/OMR Test/Online Test is conducted as a part of this selection , candidates possessing requisite qualification as per Para 7 above alone shall submit a Confirmation for writing the examination through their One Time Registration profiles. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The application of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of admission tickets will be published in the examination calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phones registered in it.

(c) The Examination Schedule and the Syllabus will be notified separately.

(d) Candidates who have AADHAAR card should add AADHAAR card as ID Proof in their profile.

**11. Special Instruction to candidate :-**

**(A)** In the case of difference in caste/community claimed in the application and that entered in SSLC Book, the candidate shall produce a Gazette notification in this regard, along with Non Creamy Layer Certificate/Community Certificate at the time of Certificate Verification.

**(B)** Candidates are required to acquaint themselves with the instruction given in the notification as Part-II, General Conditions before submitting application for the post. Applications which are not submitted in accordance with the terms and conditions laid down in the General Conditions are liable to be rejected.

**(C)** Appropriate disciplinary action as per Rule 22 of the Kerala Public Service Commission Rules of Procedure shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc., and are liable to be qualified for being considered for a particular post for debarment from applying to the Commission either permanently or for any period or the invalidation of their answer scripts or products in a written/practical test or the initiation of criminal or other proceedings against them or their removal or dismissal from office or the ordering of any other disciplinary action against them if they have already been appointed, or any one or more of the above.
