Note :- (4) Candidates included in the Short List should be present and produce the original documents for One Time Verification and interview. **Date,time and Venue of One Time Verification and interview will be intimated in due course.**

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes included in this List are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/2009/SCSTDD dated 26/09/2009 issued by Village officer and SC/ST candidates included in the List are required to produce Community Certificate (Form III or digitally signed) issued by the Revenue authority not below the rank of Tahsildar and candidates who claimed EWS reservation are required to produce EWS certificate vide GO (M S) No 2/2020/P&ARD dated 12-02-2020 issued by the Revenue Authority along with other documents at the time of One time verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **12-06-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Register Numbers of Candidates are invalidated as per Notification No : ER II (2) 4009/2023/EW dated 01/11/2023
