<p>Pradhan Mantri Sahaj Bijli Har Ghar Yojana (SAUBHAGYA)</p>	<p>Why in the news?</p> <ul style="list-style-type: none"> The Meghalaya Lokayukta has issued notifications to the former chief secretary and other former officials of the Meghalaya Energy Corporation Limited (MeECL) regarding alleged irregularities in the implementation of the Saubhagya scheme in the state. <p>About Saubhagya scheme:</p> <ul style="list-style-type: none"> Launch Date: October 2017 Objective: Universal household electrification by providing electricity connections to all un-electrified households in rural areas and poor households in urban areas. Last-Mile Connectivity: <ul style="list-style-type: none"> Electricity connections to all un-electrified households in rural areas. Free connections for BPL families in rural areas, including LED bulbs, wire, holders, switches, etc. Non-BPL families in rural areas: Connection cost of Rs. 500, payable in 10 installments of Rs. 50. Urban Areas: <ul style="list-style-type: none"> Free power connections to BPL families. Non-poor urban households are excluded from the scheme. Remote Areas: Solar Photo Voltaic (SPV)-based standalone systems for households in remote and inaccessible villages/habitations where grid extension is not feasible or cost-effective. Identification of Beneficiaries: Beneficiaries for free electricity connections identified using Socio Economic and Caste Census (SECC) 2011 data. Nodal Agency: Rural Electrification Corporation (REC) designated as the nodal agency for the Saubhagya scheme.

<p>Interest Scheme Equalisation</p>	<p>Why in the news?</p> <ul style="list-style-type: none"> ● The Department of Commerce has extended the Interest Equalisation Scheme for pre- and post-shipment rupee export credit for Micro, Small, and Medium-scale (MSME) exporters until August 31. <p>About Interest Equalisation Scheme:</p> <ul style="list-style-type: none"> ● Implementation Date: First implemented on 1st April 2015. ● Purpose: Provides pre- and post-shipment export credit to exporters in rupees. ● Initial Validity: Initially valid for 5 years, up to 31st March 2020. ● Extensions: <ul style="list-style-type: none"> ○ Extended during COVID for one year. ○ Further extensions and fund allocations have been made. ● Implementing Agency: <ul style="list-style-type: none"> ○ Implemented by the RBI through various public and non-public sector banks. ○ Banks provide pre- and post-shipment credit to exporters. ● Monitoring: Jointly monitored by the Directorate General of Foreign Trade (DGFT) and the RBI through a consultative mechanism. ● Objective: <ul style="list-style-type: none"> ○ Helps identified export sectors be internationally competitive. ○ Aims to achieve a high level of export performance.
