On ANI's defamation suit against Wikipedia

The news agency ANI sued Wikipedia parent Wikimedia Foundation last month for defamation, due to a description of the news agency as a propagator of government propaganda on the website.

What is the controversy surrounding ANI's Wikipedia page?

- ANI's page began reflecting new scrutiny of the firm's record in 2020
- An edit war ensued between seasoned editors and new accounts
- The page now describes ANI as accused of being a propaganda tool for the government
- ANI sued the Wikimedia Foundation for defamation, seeking ₹2 crore in damages
- What has the Delhi High Court ordered in the ANI-Wikipedia case?
- Ordered Wikimedia to serve summons to three users and provide their details
- Issued a verbal threat to order the Indian government to block Wikipedia if non-compliant
- Directed an "authorised representative" of Wikimedia to be present at the next hearing

How does Wikipedia face legal challenges globally?

- Faces bans and lawsuits from individuals and organizations worldwide
- In Russia, editors have been targeted with arrests and intimidation
- In Germany, a court ordered removal of older versions of an article
- In the U.S., most cases have been withdrawn or found in Wikipedia's favor

What are Wikipedia's content policies and alleged biases?

- Policies include "neutral point of view" and using "reliable sources"
- Often accused of having a progressive, liberal bias
- Conservative grievances have become part of the ANI-Wikipedia case discourse
- Some news portals, like OpIndia, have criticized Wikipedia's editorial slant

Has Wikipedia faced criticism for content vandalism in India before?

- Arshdeep Singh's page was briefly vandalized in 2022
- Then-Minister Rajeev Chandrasekhar criticized the vandalism
- Wikipedia volunteers quickly addressed the issue
- The site lacks a procedure to block access to articles after receiving court orders in India

Can Wikipedia be blocked, and what are the potential consequences?

- China has blocked Wikipedia for years
- Russia has arrested volunteer editors but not blocked the site
- Wikipedia content can be legally mirrored to a "fork" setup for censorship
- Blocking could potentially limit free expression rights for internet users in India
