3. **The candidates have been shortlisted for Group Discussion (GD) & Personal Interview (PI) on the basis of GATE-2022 marks obtained out of 100 in the order of merit in the ratio of 1:3 to the number of vacancies category-wise in each discipline** as stipulated in the Advertisement. In case two or more candidates in the same discipline and category secured equal marks in GATE 2022 and the ratio of 1:3 is increasing, all those candidates who secured equal marks will be called for Group Discussion and Interview irrespective of the above ratio.
4. Further to the number of vacancies as advertised, **17 (Seventeen)** more nos. of vacancies in the disciplines of Mechanical, Electrical & C&I have been included for recruitment against the post of Management Trainee (Technical) for Bokaro Power Supply Company (Pvt.)
