Similarly in Jan 2023, 10 AEE(E) and 73 AE(E) shall be promoted to fill EE(E) vacancies i.e. 83 EE(E) posts shall be filled. Remaining vacancies shall be filled subsequently when eligible candidates are available. AEEs shall be promoted on regular basis and AEs on adhoc basis.</p>
