Application Procedure:

- 1. Candidates are required to apply for NUCLEAR FUEL COMPLEX, Hyderabad through NAPS portal i.e., apprenticeshipindia.gov.in. All the required documents/certificates should be uploaded on portal. See Annexure-I for full details.
- 2. After applying at above mentioned portal, the candidates are selected purely on merit basis and the same shall be communicated to the selected candidates through e-mail.

3. Last date for the receipt of application is 05/11/2022.

4. Applications received after due date/incomplete are liable to be rejected.

Selection Procedure:

- 1. The Selection Committees of NFC shall go through the applications and shortlist the candidates (as per the vacancies indicated above).
- 2. Candidates shall be selected on merit basis (percentage of marks of qualifying examination). In case of tie, the percentage of marks of 10th /SSC shall be considered as tie-breaker.


<u>Date of commencement of Training:</u> Will be intimated to the shortlisted candidates through E-mail.

General Instructions:


- 1. The offer of Apprenticeship does not confer any right of employment in NFC.
- 2. There is no provision for appointment of the Apprenticeship Trainee in NFC after the completion of training and candidate cannot claim for the same.
- 3. Selected candidates shall be required to report at NFC, Hyderabad.
- 4. Age of the apprentice should not be less than 18 years as on closing date of application.
- 5. Candidates for Technician (ITI) Apprentice must have registered their names at National Apprenticeship Promotion Scheme (NAPS) portal i.e. apprenticeshipindia.gov.in and can apply through portal only.
- 6. Candidates are advised to check their emails periodically and keep the same active during the selection process.
- 7. Candidates with post-graduation are not eligible to apply.
- 8. Reservations will be applied as per provisions of the Apprenticeship Act, 1961 and Apprenticeship Rules 1992 as amended from time to time. Candidates claiming reservation under SC/ST/OBC must mention same at the time of registration in NAPS portal otherwise they will be considered in General. Also, those registered under SC/ST/OBC must bring original certificate to this effect at the time of joining.
- 9. Suppression of facts by the applicants shall lead to disqualification at any stage of the selection process.
- 10. Verification of credentials shall be done and in case of any deviation from or non-conformity with the desired qualification, candidature of the candidate shall be summarily rejected.
- 11. Selected candidates have to submit the "Medical Fitness Certificate" at the time of joining.
- 12. The apprentices are provided accommodation by this Establishment subject to availability during the training period.
- 13. Candidates shall immediately start the process of getting a Police Verification certificate of address mentioned on their Aadhaar cards. This will be required on the date of reporting for joining the apprenticeship scheme. There is no specified format for this certificate.

- 14. Candidates are required to bring the printout of the application form during physical verification of the documents. Following documents will be verified physically.
 - i. 10th/SSC Board exam Marksheet/certificate
 - ii. ITI Marksheet & National Trade Certificate
 - iii. Cast certificate (if applicable)
 - iv. Aadhaar card
 - v. Police verification certificate
 - vi. Saving Bank A/C number & pass book
 - vii. Hard copy of online application form
 - viii. COVID vaccination certificate
 - ix. Photocopies of all the above mentioned documents
 - x. 4 resent passport size photographs
- 15. Where the contract of apprenticeship is terminated for failure on the part of the apprentice to carry out the terms of the contract, the apprentice shall refund to NFC as cost of training such amount as may be determined by the Apprenticeship Adviser. In such event, the apprentices shall not be entitled to enter into another contract of Apprenticeship under the Apprenticeship Act, 1961 with any other organization
- 16. Selected candidates are entitled for stipend as per the provision of Apprentice Act, 1961.
- 17. The character & Antecedents of the selected candidates shall be verified.
- 18. The training of the Apprentice shall be terminated without intimation following unauthorized absence of the candidate to training for a period of more than 15 days.
- 19. No TA & DA shall be admissible for joining, if selected.
- 20. The selected candidates must execute a contract for a period of one year of training as per provisions of the Apprenticeship Act, 1961 and rules framed there under.
- 21. Any canvassing or personal follow up with an intention of inducing the process of selection of apprentice by and on behalf of any candidate shall lead to immediate cancellation of candidature.
- 22. In case of any dispute, the decision of the NFC Management shall be final.





3. After successful LOGIN, the candidates are required to click on APPRENTICESHIP OPPORTUNITIES and typeNUCLEAR FUEL COMPLEX in capital letters onlyagainst SEARCH BY ESTABLISHMENT NAME.
