The prescribed fee for raising objections is **Rs.50/- plus applicable Bank Service Charges per objection**. In case the objection raised is found to be correct, the Fee paid by the candidate against such valid objection shall be refunded to the candidate after deduction of applicable Bank charges. The refund will be made to the account from where the candidate has made the online payment.

3. MODE OF PAYMENT OF FEE: -

Once the objection is raised, candidates will be redirected to SBIE Pay Lite (MOPS) payment gateway to deposit prescribed fee online via SBI E-Pay Lite (MOPS) Payment Gateway, through Net Banking, Debit Cards, Credit Cards, UPI, etc.
