1. Applications are invited online for “Site Engineers” position on outsourcing basis in govt. undertaking/ GHMC/ Urban local bodies from qualified candidates through NAC Website (www.nac.edu.in) to the post of Site Engineer.
 - Submission of ONLINE applications start from Dt. 18-09-2024.
 - Last date of submission of ONLINE applications Dt. 03-10-2024 up to 5.00 p.m.

2. **IMPORTANT NOTE:** Candidates are requested to keep the details of the following documents ready while uploading their online Application if necessary.
 - i. Aadhar number, Phone number, E-mail Id
 - ii. Educational Qualification details i.e., SSC, Intermediate/ Diploma, Degree, etc. and their Roll numbers, Year of passing etc.
 - iii. Community/ Caste Certificate/ Non-Creamy Layer Certificate in case of BC’s obtained from Mee Seva/ E Seva.
 - iv. Study certificates from 4th to 10th Class to declare the local candidates.

3. **NO. OF VACANCIES :** 50.
 - NAC does not guarantee employment to all applied candidates.
 - Selection will be solely based on caste roaster, merit basis against arising vacancies in GHMC/ other Urban Local Bodies.

4. **EDUCATIONAL QUALIFICATIONS:** Applicants must possess the qualifications from a recognized University/ Institution as detailed below:

1	Site Engineer	<ol style="list-style-type: none">i) Must possess a B.E/B.Tech/AMIE in Civil Engineering of a recognized University or Institution recognized by the University Grants Commission/ AICTE with Minimum 60% marks.ii) Preference will be given to the candidates who have undergone Industry oriented Finishing School course/ PGD/CDP etc., course in National Academy of Construction.

Note: The Candidates who have obtained Degrees through Open Universities / Distance Education mode are required to have recognition by the University Grants Commission / AICTE / Distance Education Council as the case may be. Unless such Degrees had been recognised by the relevant Statutory Authority, they will not be accepted for purpose of Educational Qualification. The onus of Proof of recognition by the relevant Statutory Authority that their Degrees / Universities have been recognised, rests with the Candidate.

5. **AGE:** Minimum 21 years & Maximum 44 years.
6. **FEE:** No application fee.

 - ii. Non-Creamy Layer Certificate as per Form-VIIB /Creamy Layer Certificate as per Form-VIIC vide Memo. No. 3009/BCW/OP/2001 Government of Telangana BC welfare Department Dt.18/12/2015.(Certificate issued in the name of candidate as S/o ORD/o).
 - iii. Certificate of Residence / Nativity (where the Candidates not studied in School / Private Study).

10. The following Certificate shall be obtained from Competent Medical authority for the purpose of verification for candidates claiming reservation under “disability” category.

- i. Medical Certificate for the Blind.
- ii. Certificate of Hearing Disability and Hearing Assessment.
