## **INSTRUCTIONS:**

- 1. Candidates who have passed ITI certified by NCVT are eligible to apply.
- Reservations to SC, ST, OBC and PwD categories are applicable as per Apprentice Act, 1961.
- 3. Candidates should not have already undergone or presently undergoing Apprenticeship Training in DRDL or elsewhere.
- 4. Candidates who have been terminated from Apprenticeship training at DRDL are not eligible to apply.
- 5. Candidates terminated for two times from other establishments are not eligible to apply.

- Interested candidates satisfying the above eligibility norms are advised to apply online at <u>www.apprenticeshipindia.gov.in</u> for the period 01-Apr-2025 to 31-Mar-2026 on or before 31-Jan-2025, 1700 Hrs.
- 7. Apprentice will be engaged for one year from the date of commencement of training.
- 8. **Incomplete online applications** (i.e. no Aadhar linking; Mismatch of Date of Birth, Name & Father's name mismatch in Aadhar with SSC Certificate & Online Application etc.) and **illegible uploaded documents** will be rejected without any correspondence.
- Shortlisted candidates will receive an email notification on their registered email ID provided in the Apprenticeship Portal. Please note that no separate correspondence or communication will be sent.
- 10. Shortlisted candidates must bring all original relevant certificates at the time of verification.
- 11. Candidates who are currently employed must submit a relieving letter from their employer on their training joining date.
- 12. No TA/DA shall be admissible for verification/ interview or at the time of joining.
- 13. Stipend will be provided as per Govt. of India notifications.
- 14. Probable date of commencement of Training is 01 April 2025.

Completion of Training does not entitle the candidates any right to claim temporary / permanent job in DRDL
