The 5th Corrigendum to Advertisement No.19 of 2023-24 for recruitment to the posts of Assistant Executive Engineer (Civil & Mechanical), under the Department of Water Resources, Government of Odisha was issued vide Notice No.2361/PSC, dated 11.04.2025. In this connection, certain queries have been received at the Commission's office which require clarification.

2. **Vacancy Position:** The additional posts/revised vacancy as published in the 4th Corrigendum vide Notice No. 961/PSC dt.17.02.2024 has been withdrawn vide Notice No.2666/PSC dated 09.05.2024. So the recruitment will be conducted as per the vacancies indicated in Para-2 (A) & (B) of the Advertisement No.19 of 2023-24 dated 28.12.2023, i.e. 580 (194-w) posts for AEE (Civil) and 41(13-w) for AEE (Mechanical).
3. **Educational Qualification:** At Para-7 of 5th Corrigendum dt.11.04.2025, "they must posses B.Tech/BE Degree in Civil/Mechanical Engineering by 26.02.2024" to be read as "they must possess Degree in Civil Engineering for AEE(Civil) and Degree in Mechanical Engineering for AEE(Mechanical) from any University or Institution recognized by Government or must be an Associate Member of the Institution of Engineers (India) in Civil or Mechanical as the case may be by 26.02.2024".

5th Corrigendum to Advertisement No. 19 of 2023-24 for recruitment to the posts of Assistant Executive Engineer (Civil & Mechanical), under the Department of Water Resources, Government of Odisha.

1. The original Advertisement for recruitment of total 580 & 41 posts of Assistant Executive Engineer in Civil & Mechanical respectively under Water Resources Department was published vide Advertisement No. 19 of 2023-24 on 28.12.2023. Four Corrigenda to this Advertisement were issued and the last date of application was extended till 26.02.2024 in the 4th Corrigendum issued vide Notice No. 961/PSC, dated 17.02.2024.
2. The interim order dated 07.03.2024, passed by the Hon'ble High Court in W.P.(C) No. 596 of 2024 and similar such W.P.(C)s, directed the Opposite Parties to proceed with the selection process pursuant to Advertisement No. 19 of 2023-24 dated 28.12.2023. However, the final result of such recruitment test shall not be published without leave of this court. Accordingly, the Commission conducted the interview of candidates on 09.07.2024 & 10.07.2024 for Assistant Executive Engineer (Mechanical) vide Notice No. 3321/PSC, dated 28.06.2024 & from 16.07.2024 to 30.07.2024 for Assistant Executive Engineer (Civil) vide Notice No.3603/PSC, dated 09.07.2024 and did not publish the result thereof.
3. Now, in pursuance to the Orders dated 15.01.2025 of the Hon'ble High Court of Odisha, Cuttack in W.P.(C) No. 596 of 2024, W.P.(C) No. 10185 of 2024, W.P.(C) No. 42059 of 2023, W.P.(C) No. 8166 of 2024 & W.A. No. 948 of 2024, the period for submission of online application for recruitment to the posts of **Assistant Executive Engineer (Civil & Mechanical)**, as per Advertisement No. 19 of 2023-24 read with all earlier Corrigenda issued thereto, is further rescheduled and the live application shall be available from **22.04.2025** to **08.05.2025 (11.59 P.M.)** (Note: **08.05.2025** is the last date for submission of registered online application).
4. The candidates who are eligible in terms of **(i) Educational Qualification** provided at *Para-4* of Advertisement No. 19 of 2023-24 read with 3rd Corrigendum vide Notice No.376/PSC, dated 19.01.2024 as on the last date of application, i.e. 26.02.2024 of the Advertisement No.19 of 2023-24, **(ii) Age** as per the requirement in *Para-3* of Advertisement No. 19 of 2023-24 and **(iii)** have got valid GATE Score as specified in the 3rd Corrigendum vide Notice No. 376/PSC, dated 19.01.2024 subsequent to the last date of application, i.e. 26.02.2024 may apply in pursuance to this Corrigendum.

5. Those candidates who have already submitted their online applications by 26.02.2024 with valid GATE Score in their applications and whose applications have been processed for shortlisting for interview need not apply again. However, they will be given the option to update and upload the upgraded/enhanced valid GATE Score as specified in the 3rd Corrigendum vide Notice No. 376/PSC, dated 19.01.2024 if they have got any upgraded/enhanced valid GATE Score subsequent to the last date of application, i.e. 26.02.2024 and can furnish the same through the online application portal in "My Applications" section of <https://opscechayan.in> portal. The last date of updating the information on upgraded/enhanced valid GATE Score will be **08.05.2025 (11.59 P.M.)**. Those candidates who do not want to alter their submitted GATE Score details are not required to do anything.
6. However, those candidates who had already applied by the last date i.e. 26.02.2024, but their applications were not processed for shortlisting for interview because of non-furnishing of valid GATE Score, may enter/upload the valid GATE Score through the online application portal in "My Applications" section of <https://opscechayan.in> portal, in pursuance to this Corrigendum if they possess a valid GATE Score as specified in the 3rd Corrigendum vide Notice No. 376/PSC, dated 19.01.2024 subsequent to the last date of application, i.e. 26.02.2024. The last date for updating the valid GATE Score will be **08.05.2025 (11.59 P.M.)**.
7. For all fresh applicants as mentioned in *Para-4 supra* the educational qualification as on the last date of application and age eligibility will strictly remain the same as per the terms of the Advertisement No. 19 of 2023-24 read with all earlier Corrigenda issued thereto without any changes i.e. they must possess B. Tech / B.E. Degree in Civil/ Mechanical Engineering by 26.02.2024 and they should have attained the age of 21 (twenty one) years as on 01.01.2023 and must not be above the age of 38 (thirty eight) years as on 01.01.2021 i.e. he or she must be born not earlier than 02.01.1983 and not later than 01.01.2002.
8. The marks secured by the candidates in the interview who had already appeared for the interview vide Notice No. 3321/PSC, dated 28.06.2024 for AEE (Mechanical) & Notice No. 3603/PSC, dated 09.07.2024 for AEE (Civil) will remain valid and will be taken into account in preparation of the final Select List as per "Method of Selection" in *Para-5* of the Advertisement No. 19 of 2023-24.
9. All other terms and conditions specified in Advertisement No. 19 of 2023-24 along with all earlier Corrigenda issued thereto shall remain unchanged.

- The probation period of the above posts is two years.
- In the event of non-availability or availability of insufficient number of eligible women candidate(s) belonging to any particular category, the remaining vacancies will be filled up by male candidate(s) of that category.
- Exchange of reservation between Scheduled Caste and Scheduled Tribe will not be considered in the event of non-availability of eligible and suitable S.C./S.T. candidates.
- Candidates belonging to the categories of Persons With Disabilities and Sports Persons shall be adjusted against the categories to which they belong.

3. AGE: A candidate must have attained the age of 21 (twenty one) years as on 01.01.2023 and must not be above the age of 38 (thirty eight) years as on 01.01.2021 i.e he or she must be **born not earlier than 02.01.1983 and not later than 01.01.2002.**

Age relaxation for candidates in different categories for availing relaxation and reservation benefits will be as per Government Rules prescribed for the purpose. The upper age limit is relax-able by 5(five) years for candidates belonging to the categories of Scheduled Castes (S.C.), Scheduled Tribes(S.T.), Socially & Educationally Backward Class(S.E.B.C.), Women, Ex-servicemen, and by 10(ten) years for Persons With Disabilities category, whose permanent disability is 40% and more.

Persons with Disabilities belonging to the categories of SC/ST/SEBC shall be entitled to cumulative age relaxation benefit of 15 years.

Provided that the maximum age limit shall be relaxed to 45 years in respect of the candidates who have entered the Diploma Engineers' Service as Junior Engineers whether promoted to the post of Asst. Engineer or not within the prescribed age limit without the qualification prescribed under Clause (b) of Rule 6 and have subsequently acquired the same while serving as such or have acquired such qualification prior to entering the State Government Service as Junior Engineers subject to availing of not more than 5 chances.

Provided that a candidate who comes under more than one category mentioned above he/she will be eligible for only one age relaxation benefit.

SAVE AS PROVIDED ABOVE THE AGE LIMITS PRESCRIBED CAN IN NO CASE BE RELAXED.

Date of birth entered in the high school certificate or equivalent certificate issued by the concerned board/council will only be accepted by the Commission.

4. EDUCATIONAL QUALIFICATION: A candidate must have possessed a **Degree in Engineering in Civil** for the post of **AEE (Civil)** and **Degree in Engineering in Mechanical** for the post of **AEE (Mechanical)** or an equivalent qualification from any University or Institution recognized by the Government or he/she must be an Associated Member of the Institution of Engineers of India in Civil/Mechanical.

5. METHOD OF SELECTION:

- i. The Commission after receipt of all the applications shall take steps to select the candidates on the basis of valid Graduate Aptitude Test in Engineering (GATE) score and interview.
- ii. The merit list shall be prepared on the basis of aggregate marks secured in valid Graduate Aptitude Test in Engineering (GATE) score carrying 90% weightage and interview carrying 10% weightage.
- iii. In case of two or more candidates securing the same marks in aggregate, the candidate securing higher marks in interview will be assigned higher position over the others.
- iv. In case of securing higher marks in interview, final ranking will be determined on the basis of age, i.e, those elder in age will be given preference over others.
- v. The Commission, shall short list the candidates for interview on the basis of valid Graduate Aptitude Test in Engineering (GATE) score which shall be two times of the vacancies advertised, category wise:

Provided that the candidates securing same marks at the cut-off point of each category would be admitted for interview even it exceeds two times of the vacancies advertised.

NOTE :- (a) Candidates are to upload their **"Certificate showing valid GATE score"** along with online application.

(b) Any details relating to this recruitment like cut-off scores, individual scores, etc. shall only be declared on the website of the Commission after publication of the final result and select list.

6. APPLICATION FEE: The candidates are exempted for payment of examination fees as per G.A Deptt. letter No.9897/Gen dated 11.04.2022.

7. OTHER ELIGIBILITY CONDITIONS:

- (i) The candidate must be a citizen of India;
- (ii) He/She must be of good character and of sound health and free from any organic defect and physical infirmity likely to interfere with the discharge of his/her duties in the service.
- (iii) He/She must be able to read, write and speak Odia and have -
 - (a) Passed Middle School Examination with Odia as a language Subject; or
 - (b) Passed Matriculation or equivalent Examination with Odia as medium of examination in non-language subject; or
 - (c) Passed in Odia as language subject in the final examination of Class-VII from a School or Educational Institution recognized by the Government of Odisha or the Central Government; or
 - (d) Passed a test in Odia in Middle English School Standard conducted by the School and Mass Education Department/Board of Secondary Education, Odisha
- (iv) A candidate, who has more than one spouse living, will not be eligible for appointment unless the State Government has exempted his/her case from operation of this limitation for any good and sufficient reasons;

- (v) Government servants, whether permanent or temporary or on probation against a vacancy in permanent/temporary posts in any department of Government, are eligible, provided they possess the requisite qualification and are within the prescribed age limit as mentioned under Para-3 and Para-4 of this advertisement. They must inform their respective Heads of the Office in writing regarding submission of their application for this recruitment and furnish "No Objection Certificate" during document verification;
- (vi) If a candidate has at any time, been debarred for a certain period/chance(s) by the Odisha Public Service Commission or by other State Public Service Commission or by U.P.S.C. from appearing at any examination / viva voce test, he/she **will not be eligible** for such recruitment for that specified period / chance(s);
- (vii) **Only those candidates, who possess the requisite qualifications, are within the prescribed age limit and fulfill other eligibility conditions etc. by the closing date for submission of online application form, will be considered eligible;**
- (viii) A candidate who claims change in his/her name after having passed the H.S.C. examination, is required to furnish copy of publication of the changed name in the local leading daily newspaper as well as copy of notification in the Gazette in support of his/her change of name;
- (ix) Every candidate selected for appointment shall be examined by the Medical Board. A candidate, who does not satisfy the requirement after medical examination, shall not be appointed.

8. IMPORTANT POINTS:

- (i) **Online applications submitted to OPSC, if found to be incomplete in any respect, are liable for rejection without entertaining any correspondence with the applicants on the score;**
- (ii) A candidate found guilty of seeking support for his/her candidature by offering illegal gratification or applying pressure on any person connected with the conduct of the recruitment process or found indulging in any type of malpractice in course of the selection or otherwise, shall, in addition to rendering himself/herself liable to criminal prosecution, be disqualified not only for the recruitment for which he/she is a candidate, but also may be debarred, either permanently or for a specified period, from any recruitment or selection to be conducted by the Commission;
- (iii) **Admission to recruitment process will be provisional. If on verification at any stage of the recruitment process it is found that a candidate does not fulfil all the eligibility conditions, his/her candidature will be liable to rejection. Decision of the Commission in regard to eligibility or otherwise of candidate shall be final;**
- (iv) This advertisement should not be construed as binding on the Government to make appointment;
- (v) Concession meant for S.E.B.C, S.C & S.T by birth are admissible to the Socially and Educationally Backward Classes, Scheduled Castes & Scheduled Tribe of Odisha only;

- (vii) Mere empanelment in the select list shall not confer any right for appointment unless the Government is satisfied after making such enquiry as may be deemed necessary that the candidate is suitable in all respects for appointment to the service.

9. CERTIFICATES/DOCUMENTS TO BE ATTACHED:

Only those candidates, who are called for document verification are to submit the printout/hard copy of online applications, along with true copies of the following documents duly self attested by the candidates with full signature and date on the same on the day of document verification. They must also produce original certificates, mark-sheets etc. for verification on the date fixed by the Commission.

If a candidate fails to produce any of the original documents in respect of the self attested copies submitted with the application form on the date of document verification fixed by the Commission, his/her candidature will be rejected.

- (i) H.S.C. or equivalent certificate in support of declaration of age issued by the concerned Board/Council.

NOTE 1:

(a) Candidates who have not been awarded percentage of marks, but only "grade marks", should, along with their applications, produce the Conversion Certificate from the concerned University indicating the actual equivalent percentage of marks and the conversion formula, failing which, their applications are liable to be rejected.

- (viii) Certificates of character and conduct from the Principal/Proctor/Dean or Professor in charge of teaching department of the College or University in which he/she last studied;
- (ix) **Caste Certificate by birth in support of claim as SC/ST/SEBC, wherever applicable;**

NOTE 2:

Candidates claiming to be belonging to S.C. /S.T./ S.E.B.C category by birth are required to submit copy of the relevant Caste Certificate issued by the competent authority in the prescribed form. Candidates of SEBC category (other than Creamy Layer) must submit copy of Caste Certificate issued by the competent authority within the last three years from the last/closing date of submission of online application.

- a. Women candidates belonging to S.C. /S.T. /S.E.B.C Categories are required to submit Caste Certificates by birth showing "daughter of". Caste Certificates by virtue of marriage (i.e. showing "wife of") is not acceptable.
- b. O.B.C. Certificate Will Not Be Accepted in lieu of SEBC Certificate and candidates submitting the OBC Certificate are liable for rejection.
- c. Community (Caste status) once mentioned by the candidates shall not be changed under any Circumstances.

The competent authorities are:-District Magistrate/ Collector or Additional District Magistrate or Sub-divisional Magistrate/Sub-Collectors or Executive Magistrates or Revenue Officers, not below the rank of Tahasildar /Additional Tahasildar of Government of Odisha;

- (x) Required Odia Pass Certificate from the Board of Secondary Education, Odisha indicating Odia as a language subject equivalent to M.E. School Standard or a certificate from the Principal/Headmaster of the recognized school indicating that the candidate has passed Odia upto M.E. standard; if not passed Odia as a subject in the High School certificate examination or equivalent examination;
- (xi) Disability Certificate (indicating percentage of permanent disability) issued by the concerned Medical Board, wherever applicable;
- (xii) If a candidate claims to possess qualification, equivalent to the prescribed qualification, the rule/authority (with number and date) under which it is so treated, must be furnished with the print out/hardcopy of online application form.

Deptt. notification No. 22586-Gen., dt.16.10.1985], Sports Identity Card issued by the Director of Sports, Odisha must have been issued by the competent authority within the last date fixed for receipt/submission of application form as indicated above.*

- (f) Not having requisite qualification as provided under Para - 4 of Advertisement.
