The National Testing Agency (NTA) has successfully conducted UGC NET December 2022, Phase-I and II for 62 subjects. UGC NET December 2022 [Phase III, 08 Subjects] will be over on 06 March 2023.

No examination are scheduled from 07 March 2023 to 10 March 2023.

The NTA is now displaying the Advance Intimation for Allotment of Examination City for UGC NET December 2022 [Phase IV, 04 Subjects] scheduled to be held between 11 March 2023 and 12 March 2023. Subject-wise details are mentioned in **Annexure-1**.
