**PUBLIC NOTICE**

**Sub: Public Notice for drawing a panel of Special Education Teachers & posts of Inclusive Education Cadre in DoE, GNCTD.**

Online applications are invited on behalf of Director (Education), GNCT of Delhi to draw a panel of Guest Teachers for the following posts in Govt. Schools of Delhi, on the basis of requirement, for academic session 2023-24:

Engagement of Guest Teachers is subject to following terms and conditions:

1. Guest Teachers shall be engaged purely on daily wages basis, till the posts are filled up on regular basis. Guest teachers shall not be entitled to regular appointment. This is purely a stop gap arrangement. The candidates so engaged shall not claim salary, allowances, leaves, facilities and other benefits accruing to the regular teachers. The candidates so engaged as Guest Teachers shall not file any court case regarding salary and regularization etc.
2. Directorate of Education will maintain a wait list/panel of candidates to meet any requirement in the academic session 2023-24 and onwards. Further, the engagement will be done on the basis of as and when required.
3. Reservations and age relaxations to the candidates belonging to SC/ST/OBC/EWS and benchmark persons with disabilities will be given as per Government Rules. The certificate of OBC should be issued by Authority of Govt. of NCT of Delhi. Certificate issued by any State/UT will be considered for SC/ST candidates. The candidates belonging to PwDs category must possess "Disability Certificate" issued from a Government Hospital.
4. The panel will be prepared on the basis of academic merit separately for each category of applicants including SC/ST/OBC/EWS/PwD and other.
5. The Guest Teachers shall be paid as per the rates mentioned in the following table which have been approved by Hon'ble L.G. GNCTD vide U.O. No. 27930 dated 23.02.2017 and 03.03.2017:

6. Request for change of school shall not be entertained at any time during the engagement. If the person does not join within given time the offer of appointment will be cancelled.
7. As soon as a regular teacher joins the school the Guest teacher will be disengaged from that school, irrespective of his/her standing in the order of merit list for the purpose of engagement.

8. The merit list will be displayed on the website after document verification by Inclusive Education Branch. The shortlisted candidates will be called for engagement as Guest Teachers as and when required by school.

10. Age as on Last Date of submission of application:

- Maximum age for male candidate of General category is 30
- Relaxation of age to the reserved categories will be as follows
- Relaxation of 5 years in case SC/ST candidates
- Relaxation of 3 years in case of OBC candidates Relaxation for Persons with Disabilities candidates 10 years in case of General (Persons with Disabilities)
- 15 years in the case SC/ST (Persons with Disabilities) and 13 years in the case of OBC (Persons with Disabilities)
- Additional relaxation of age 10 years in case of Female candidates applying for the Post of TGT Special Education Teacher

11. **Reservation of Posts:** The reservation will be allowed as per the policy of Services Department, Govt of NCT of Delhi

12. **Tenure:** The engagement of Guest Teachers for the current academic session i.e. 2023-24 will be up to 10/05/2024 or the commencement of the summer vacation or till the time the posts are filled on regular basis, whichever is earlier.

13. **Mode of Selection:** The eligible candidates should submit their applications online in the prescribed format. And accordingly merit list shall be prepared for the said posts.
14. Willing candidates may apply and register themselves on the online module of the departmental website, through the following link: [edudel.nic.in](http://edudel.nic.in)---RRs/Recruitment---Guest Teachers Recruitment for 2023- 24 from 30.09.2023 (11.00 AM) to 15.10.2023 (up-to 6.00 PM). **Submission of applications other than online mode shall be summarily rejected. Applicants are strictly instructed not to send any hard copy of the application to this department.**
15. The order of Merit list shall be displayed on the departmental website. Further, documents verification related to age, qualifications, caste certificate etc. will be conducted by HOS concerned. The selected candidates will be called for engagement as guest teacher, as per the requirement.
16. **Only one application for a particular post shall be entertained. Candidature of the applicants who have filled applications more than once will be summarily rejected.**

**OTHER IMPORTANT CONDITIONS:**

1. Percentage of marks must be entered up to two places of decimal.
2. The candidate shall use, Google chrome browser only while filling up application online.
3. The candidate shall fill-up his/her name, Date of Birth, roll number, year of passing etc. as they appear in the pass certificate of class XII Examination. Any deviation in this regard will lead to disqualification. Candidates in their own interest are advised to fill up all the items in the online application form carefully and before submitting the form online he/she shall check the particulars on the "Preview" Screen. Requests for correction what so ever shall not be entertained at later stages.
