### 1. Professor (On Direct Recruitment Basis):- University School of Education (USE), University School of Mass Communications (USMC), University School of Liberal Arts (USLA), and University School of Humanities & Social Sciences (USHSS):

#### **Eligibility:**

1. (A) (i) An eminent scholar having a Ph.D. degree in the concerned/allied/relevant discipline, and published work of high quality, actively engaged in research with evidence of published work with a minimum of 10 research publications in the peer-reviewed or UGC-listed journals and a total research score of 120 as per the criteria given in Appendix II Table 2 of UGC Regulation 2018.

(ii) A minimum of ten years of teaching experience in university/college as Assistant Professor/Associate Professor/Professor, and / or research experience at equivalent level at the University/National Level Institutions with evidence of having successfully guided doctoral candidate.

**OR**

(B) An outstanding professional, having a Ph.D. degree in the relevant/allied/applied disciplines, from any academic institutions (not included in A above) / industry, who has made significant contribution to the knowledge in the concerned/allied/relevant discipline, supported by documentary evidence provided he/she has ten years' experience.

### 2. Associate Professor (On Direct Recruitment Basis) in University School of Liberal Arts (USLA) and University School of Humanities & Social Sciences (USHSS) :

#### **Eligibility:**

- (i) A good academic record, with a Ph.D. Degree in the concerned/allied/relevant disciplines.
- (ii) A Master's Degree with at least 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed).
- (iii) A minimum of eight years of experience of teaching and / or research in an academic/research position equivalent to that of Assistant Professor in a University, College or Accredited Research Institution/industry with a minimum of seven publications in the peer-reviewed or UGC-listed journals and a total research score of Seventy five (75) as per the criteria given in Appendix II, Table 2 of UGC Regulation 2018).

### 3. Assistant Professor (On Direct Recruitment Basis) in University School of Liberal Arts (USLA), University School of Law & Legal Studies (USLLS), University School of Humanities & Social Sciences (USHSS) and University School of Management Studies (USMS):

#### **Eligibility (A or B):**

**A.**

- i) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading System is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
- (ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET:

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:-

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
- e) The candidate has presented at least two papers based on his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.

The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

**Note:** NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

OR

**B.** The Ph.D degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

**Note:** The Academic score as specified in Appendix II (Table 3A) for Universities, as per UGC Regulations 2018, shall be considered for short-listing of the candidates for interview.

**Note :** As per UGC notification No. F.9-42/2023(PS/Misc.) dated 06.07.2023, it is mentioned clearly that NET/SLET/SET is the minimum requirement for the direct recruitment of an Assistant Professor for those who do not have a Ph.D. degree. But holders of Ph.D. degrees awarded as per UGC Regulations and its amendments are exempted from NET/SLET/SET and thereby eligible for direct recruitment to the post of Assistant Professor.

3. Age relaxation, in respect of SC/ ST/ OBC/ Persons with benchmark Disabilities (PwBD)/ Ex-Serviceman candidates etc. and regular government employees will be as per rules. The age relaxation to employees of GGSIP University will be provided as per University policy.

5. In case of large number of applications, candidates will be shortlisted based on their Academic Research Score/ Experience etc. as decided by the University and University may adopt any mode of test. In case of written test, admit card will be issued online to eligible candidates on University website. The scheme of examination and syllabus will be informed well in advance on the University website.
6. No TA/ DA in connection with the submission of application form or appearing in screening test/ presentation/ interview will be paid to the candidate.
7. Prescribed Educational Qualifications are minimum and mere possession of the same does not entitle candidates to be called for interview. Where numbers of applications received are more, the University reserves the right to shortlist the candidates to be called for presentation/interview in any manner as may be considered appropriate.
8. No documents will be accepted or considered by the University after submission of application form by the candidate and no subsequent request for its change will be considered or granted.
9. The fee once paid will not be refunded to the candidate in any circumstances. Hence, it is the responsibility of the candidate to ensure about his/ her eligibility before submitting the online application. In case of any dispute/ ambiguity that may occur in the process of selection, the decision of the university shall be final.
10. If the qualification possessed by the candidate is equivalent, then the authority (with number and date) under which it has been so treated must be indicated and its copy must be attached.
11. All candidates are requested to ensure submission of duly filled in Appendix-II Table-II for the post of Professor and Associate Professor and Appendix-II Table-3A in case of Assistant Professor in the Universities. In absence of above appendix as applicable, the application of candidate will be summarily rejected and no further correspondence will be entertained.
12. As per provision under Statute 31 of the University, the selected candidates on regular basis shall be on probation on such post for a period of twenty four months provided that the appointing authority may extend the period of probation for a period of another twenty four months.
13. The shortlisted candidate will be called for Document Verification on scheduled date and time as informed by the University on University website as well as through e-mail. At the time of Document verification, candidates should carry all their original documents and testimonials for verification along with a hardcopy of duly filled-in application form submitted in online mode with a copy of all educational qualifications, reprints of research publications, teaching/ working experience certificates/ last pay drawn etc for submission.
14. The Academic score as specified in Appendix II (Table 3A of UGC Regulations No. F.1-2/2017(EC/PS) dated 18/07/2018) (for Universities) shall be considered for short-listing of the candidates for interview.
15. Eligibility conditions as amended by AICTE / UGC / COA / PCI from time to time shall be applicable. Relaxation in qualification / age for SC/ST/OBC/EWS/PWD shall be as per UGC norms as applicable. The OBC candidates must be in possession of Non Creamy Layer certificate issued during current financial year along with his/ her caste certificate issued by Delhi.
16. In case of Contract appointment, the initial appointment will be for a period of one year which may be extendable subject to performance and the requirement of the University. The contract appointment may also be terminated with one month notice on joining of regular faculty.
17. This advertisement may be read with attached "General Instructions and Guidelines".

18. All applicants who are presently employed in Government/Semi Govt./Public Sector Undertaking/University/Recognized Educational Institute etc. should submit through proper channel enclosing a certificate from the Government organization stating no Vigilance or Disciplinary case is pending or contemplated against them and also submit a no objection certificate from present employer at the time of interview. **Reservation Benefits:**

- (i) Reservation benefits will be available to the SC/ST/OBC/EWS candidates in accordance with the extant Instructions / Orders / Circulars issued from time to time by the Govt. of NCT of Delhi/DOP&T, Govt. of India.
  - (ii) Candidates who wish to be considered against reserved vacancies must be in possession of relevant certificates (SC/ST/OBC & Non Creamy layer/EWS) issued by the competent/notified authority (in prescribed format) on or before the last date of submission of application, i.e., **24<sup>th</sup> December, 2024** otherwise their claim for any category will not be entertained and their applications will be considered against Un-reserved (UR) category vacancies, if eligible otherwise.
