Subject: Contempt notice for non-compliance of order dated 05.08.2024 passed in W.P.(C) 5916 of 2022 by Hon'ble Delhi High Court for failure to recruit and appoint Special Educators

Dear Madam,

Take notice that Hon'ble Delhi High Court by order dated 05.08.2024 (Copy enclosed) passed in W.P.(C) 5916 of 2022 titled 'Social Jurist, A Civil Rights Group versus Kendriya Vidyalaya Sangathan & Anr', directed Kendriya Vidyalaya Sangathan to forthwith frame Recruitment Rules and Conditions of Service as well as commence the process of Recruitment and Appointment of Special Educators and complete the process within six months of the order. Relevant part of the Order dated 05.08.2024 is reproduced as under:

- "1. Learned counsel for Union of India states that the Ministry of Finance, Department of Expenditure has approved creation of 987 posts of Teachers having qualification of Special Educators (Pay Level 6/7) as approved by the Rehabilitation Council of India in Kendriya Vidyalayas.
- 2. He further states that the Department of School Education and Literacy vide letter dated 5th July, 2024 has

ordered for sanctioning of 987 posts of Special Educators (Pay Level 6/7) in Kendriya Vidyalayas.

3. In view of the aforesaid development, the respondent no.1 is directed to frame Recruitment Rules and Conditions of Service as well as commence the process of Recruitment and Appointment of Special Educators forthwith. The said process is directed to be completed within six months.

4. With the aforesaid directions, the writ petition and application stand disposed of."

Take notice that despite specific order dated 05.08.2024 passed in W.P.(C) 5916 of 2022 titled 'Social Jurist, A Civil Rights Group versus Kendriya Vidyalaya Sangathan & Anr', you have deliberately and intentionally done nothing even after expiry of 6 months as stipulated in the order.

Take notice that due to your intentional and deliberate disobedience of the Hon'ble Delhi High Court orders dated 05.08.2024, education of CWSN students studying in schools running under Kendriya Vidyalaya Sangathan is suffering.

Take notice that your aforesaid deliberate disobedience of the Hon'ble Delhi High Court orders tantamount to contempt of Hon'ble Delhi High Court and attracts punishment against you.
