- 1. Applicants are required to apply online (through Link: https://curec.samarth.ac.in). The online link will be available till 21.04.2025 (by IST 05:00 PM).
- 2. The direct recruitment to the posts of Assistant Professor, Associate Professor and Professor in the University shall be on the basis of merit through all India advertisement and selections by the duly constituted Selection Committees.
 - 3. Before applying, please read the following extract of Office Order No. CUPB/Estt./2024/OO/210 Dated 02.08.2024, which is given below:
