


AFSPA extended in Nagaland, Arunachal Pradesh




- •The *Ministry of Home Affairs (MHA)* has extended the *Armed Forces (Special Powers) Act (AFSPA)* in parts of **Arunachal Pradesh** and *Nagaland* for another six months.
- •Sweeping powers to the armed forces: It allows them to open fire, even causing death, against any person in contravention to the law or carrying arms and ammunitio
- •Power to arrest: It gives them powers to arrest individuals without warrants, on the basis of "reasonable suspicion", and search premises without warrants.
- •Disturbed" under Section 3: It can be imposed by the Center or the Governor of a state, on the state or parts of it, after areas are declared "disturbed".



AFSPA extended in Nagaland, Arunachal Pradesh



- •The *Ministry of Home Affairs (MHA)* has extended the *Armed Forces (Special Powers) Act (AFSPA)* in parts of **Arunachal Pradesh** and *Nagaland* for another six months.
- •Amendment in 1972: The powers to declare an area as "disturbed" were conferred concurrently upon the *Central government* along with the *States*.
- •Home ministry: Currently, the Union Home Ministry issues periodic "disturbed area" notification to extend AFSPA only for Nagaland and Arunachal Pradesh.
- •State government: The notification for Manipur and Assam is issued by the State governments.




UNESCO launches list documenting 50 iconic Indian heritage textiles

 - Russia used a veto to block it.

SASTRA Ramanujan Prize 2022



•The SASTRA Ramanujan Prize for 2022 will be awarded to Yunqing Tang, Assistant Professor with the University of California, Berkeley, U.S.A.

Yunqing Tang awarded for:

- •Display a remarkable combination of sophisticated techniques, in which the *arithmetic* and *geometry* of *modular curves and of Shimura varieties* play a central role.
- •Her results and methods are bound to have a major impact on future research in this area.

SASTRA Ramanujan Prize 2022



SASTRA Ramanujan Prize:

- •The award, instituted by the *Shanmugha Arts, Science*, *Technology & Research Academy (SASTRA) in 2005* with a cash prize of \$10,000.
- •It is presented annually to individuals aged *32 and below,* who made outstanding contributions in the field of *mathematics*, influenced by *Srinivasa Ramanjuan*.

SASTRA Ramanujan Prize 2022



- •Ramanujan was born on 22nd December 1887 in a village Erode (400 km from *Chennai*, then known as Madras).
- •Ramanujam made substantial contributions to the *analytical* theory of numbers and worked on elliptic functions.
- •He also worked on the *partition of the whole* number, hypergeometric series and *Euler's constant*.
- •In India, *December 22nd* is celebrated as *National Mathematics Day in the memory of Srinivasa Ramanujan*.





Submarine Launched Ballistic Missile (SLBM) test Adda 247



Context: Nuclear-powered INS Arihant carries out successful launch of SLBM

Significance:

It will help in a robust, survivable and assured retaliatory capability in keeping with India's policy to have 'Credible Minimum Deterrence' that underpins its 'No First Use' commitment."

·It increases the second-strike capability of India and thus boosts its nuclear deterrence.

Submarine Launched Ballistic Missile (SLBM) test Adda 247



India's nuclear-powered ballistic missile submarine (SSBN) programme is a closely guarded project. INS Arihant was the first boat under the SSBN project followed by another boat, INS Arighat. SSBN programme is a key element of India's nuclear deterrence capability.

Submarine Launched Ballistic Missile (SLBM) test Adda 24

•INS Arihant, a 6,000-tonne submarine is the lead ship of India's Arihant class of nuclear-powered ballistic missile submarines built under the Advanced Technology Vessel (ATV) project.

•About:

- ·It completed India's nuclear triad (the capability to retaliate against a nuclear strike from land, air and sea).
- •INS Arihant is propelled by an 83 MW pressurised light-water reactor at its core with enriched uranium fuel.

Submarine Launched Ballistic Missile (SLBM) test

Adda 247

K-4 (range 750km) and K-15 (3500 Km) have been designed to be operated from the Arihant class of submarines.

'Ship Submersible Ballistic Nuclear Submarine' (SSBN).

SSBN's are those class of submarines which can go deep beneath the ocean making them virtually undetectable for months, they also carry nuclear-tipped ballistic missiles.

Project-75 India (P75-I)



Context: Citing difficult to fulfil conditions set in the request for Proposal (RFP), previously Russia pulled out of the P-75l project (for the construction of 6 advanced submarines)

What is the P-75 Project?

- It is part of the Indian Navy's 30-year Plan for indigenous submarine construction- P-75 (1st Phase) and P-75I (2nd phase)
- P-75 (signed in 2005): to build 6 Scorpene class (diesel-electric) submarines (contract signed between India and France)

Project-75 India (P75-I)



What is the P-75I project?

Project 75-I (approved in 2007) is 2nd phase of the Indian Navy's 30-year Planfor indigenous submarine construction.

It envisages the indigenous construction of 6 modern conventional submarines with:

- Non-nuclear or diesel-electric engine
- Contemporary equipment, weapons & sensors
- Fuel-Cell based AIP (Air Independent Propulsion)
- Advanced torpedoes and modern missiles

Project-75 India (P75-I)



It is also the first programme to be progressed under the **Strategic Partnership concept** which offers a **level-playing field to the private sector**.

Why countries have Pulled out?

The conditions put in Transfer of technology, stealth technology, construction in India as well as Air Independent Propulsion System were very much advanced and no prototype of it is available of it yet.

 Previously, Sweden, France and Germany had also pulled out of the project.




