Online applications are invited from the eligible candidates for two-year D.El.Ed. Course for the academic session, 2023-2025 in **30 DIETs, 04 BIETs, 31 Government Elementary Teacher Education Institutions (ETEIs), 02 Government Elementary Teacher Education Institutions (SC & ST Development) and 01 Non Government Aided Secondary Training School managed by Minority Community of the State.**

**1.0 DURATION AND WORKING DAYS OF THE COURSE :**

**1.1 Duration :**

The D.El.Ed. programme shall be of a duration of two academic years.

**1.2 Working Days :**

There shall be at least **200 working days each year** exclusive of the period of Examination and admission. The **minimum attendance** of student teacher shall have to be **80%** for all course work and practicum, and **90% for school internship.**

### 3.0 Eligibility to apply for the Specific Course :

Sl. No.	Name of the Course / Specific Course	Who can apply ?
1.	D.El.Ed. (OOT Quota)	Any eligible candidates (as per eligibility criteria) from the state irrespective of their district and Outlying Odia Tract (OOT) candidates
2.	D.El.Ed. (BIET Quota)	SC and ST eligible candidates (as per eligibility criteria) of the concerned district where the BIETs are situated (Mayurbhanja, Nawarangpur, Rayagada and Sundargarh)
3.	D.El.Ed. (Santali)	Any eligible candidates (as per eligibility criteria) who can read and write Santali
4.	D.El.Ed. (Telugu Quota)	Any eligible candidates (as per eligibility criteria) of the state who have Telugu as MIL or a subject at HSC level
5.	D.El.Ed. (Urdu Quota)	Any eligible candidates (as per eligibility criteria) of the state who have Urdu as MIL or a subject at HSC level
6.	D.El.Ed. (Christian Community)	Any eligible women Christian candidates (as per eligibility criteria) of the state
7.	D.El.Ed. (Kandhamal Quota)	Any eligible candidates (as per eligibility criteria) of Kandhamal district only

**Note :** An eligible candidate can apply for any one option only out of the above seven categories.

#### 4.0 Eligibility for D.El.Ed. Course (All) :

The candidate must fulfill all the eligibility conditions given below :

- 4.1** The candidate must have passed Higher Secondary / +2 Examination in Arts / Science / Commerce or its equivalent examination from recognized Boards / Councils (the candidates shall have to submit equivalent certificate from the competent authority) with a minimum of **50% of marks in aggregate (45% of mark** in aggregate in case of **SC, ST, SEBC and PH** candidates) excluding marks secured in extra optional.

The candidates who have appeared their final year Higher Secondary / +2 Examinations in Arts / Science / Commerce or its equivalent examination from recognized Boards / Councils are also eligible to apply. Their candidature for admission is subject to the required aggregate percentage of mark at Higher Secondary level during the time of their admission, failing which his / her selection will be cancelled.

- 4.2** She / he must have passed Odia as MIL up to HSC level or any such equivalent or higher examination (+2) or have passed Odia in single subject Examination conducted by BSE, Odisha of HSC standard or should have passed HSC Examination of BSE, Odisha in Odia medium with MIL other than Odia. Such candidates who have passed HSC Examination of BSE, Odisha without Odia as MIL should produce a certificate to the effect from the Headmaster of the concerned school that he / she has passed HSC Examination in Odia medium.

- The candidates seeking admission in D.El.Ed. (Urdu) at Government ETEI, Urdu, Cuttack (100 seats) and in 25 seats of ETEI, Pahimadura, Bhadrak must have passed Urdu as MIL up to HSC standard / equivalent examination as notified by Board of Secondary Education, Odisha, Cuttack.
- The candidates seeking admission in D.El.Ed. (Telugu) at Government ETEI, Telugu (50 seats) must have passed Telugu as MIL up to HSC standard / equivalent examination as notified by Board of Secondary Education, Odisha, Cuttack.

**4.3 The age limit as on 30.06.2023 :**

For SC, ST, SEBC Candidates	<b>35 years</b>	She / he should not have born before 30.06.1988
For Women Candidates of all categories	<b>35 years</b>	She should not have born before 30.06.1988
For General Candidates	<b>30 years</b>	He should not have born before 30.06.1993
For PH Candidates	<b>40 years</b>	She / he should not have born before 30.06.1983

**Note :** The upper age limit is inclusive of age relaxation for relevant groups as admissible under Rules

**4.4 Residential Certificate :**

- The candidates except Outlying Odia Tract (OOT) category must be permanent residents of Odisha. To that effect each candidate shall furnish

a permanent residential certificate (**issued after 30.06.2022**) in the prescribed format issued in favour of him / her by the Tahasildar / Additional Tahasildar concerned.

#### **4.5 Caste Certificate :**

- In case of SC, ST and SEBC candidates, the Caste Certificate should be issued by the concerned Tahasildar / Additional Tahasildar. **The Caste Certificate shall be considered by virtue of birth only (Caste by marriage or adoption will not be considered).**

#### **4.6 PH Candidates:**

##### **Candidates with Disabilities**

- Pursuant to the provisions of Section 32 (1) of the Rights of Persons with Disabilities Act, 2016, **five** percent seats shall be reserved for candidates with benchmark disabilities of the following categories, who are fulfilling the physical requirement and functional classification of the job role for which the course is pursued:
  - a) Blindness and low vision.
  - b) Deaf and hard of hearing.
  - c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy.

***Note: Candidates with Disabilities of different categories and diagnosis not fulfilling the physical requirement and functional classification of the job role of the course to be pursued as per provisions of identification of posts issued vide GA Deptt. Resolution No. 34450 dated 3<sup>rd</sup> September 2013 shall not be considered for the course.***

- All candidates with benchmark disabilities are required to submit UDID (Unique ID for Persons with Disabilities) disability certificate issued online in their favour vide **<http://www.swavlambancard.gov.in/>** along with application for availing reservation under PwD quota.
- All the shortlisted candidates under Person with Disability category shall immediately be referred to the Appellate Authority appointed under Section 59(1) of the Rights of Persons with Disabilities Act, 2016 for verification by relevant Medical Assessment Board formed under Rule 12(4) of Odisha Rights of Persons with Disabilities Rules, 2018 for verification of genuineness of certificate of benchmark disability.
- Candidates with benchmark disabilities duly verified and cleared by the Appellate Authority with not less than 40% disability will be allowed for admission to the course.
- The students with benchmark disabilities shall be allowed compensatory time of 20 minutes per hour during examination.
- Candidates must have capacity of speaking, hearing (with suitable aids), reading and writing essential for teaching job.
- The students with benchmark disabilities admitted to the Course will pursue their studies within the existing facilities available in the institution until special provisions are being made for them.

#### 4.6.1 Provision for Scribe

- As per State Government Resolution issued on 05.09.2017 in para 14 (4) the facility of Scribe / Reader shall be provided to any PwD with not less than 40% of Disability provided he / she has limitation in writing or that of speed.
- The candidates with scribes should be provided with the proper sitting arrangement in the examination hall preferably one candidate in each room or if there is space constraint, one candidate in each corner of a room.
- The educational qualification of the Scribe should not be same / similar that of the candidate. The examination center superintendents are to ensure this. Examples: A candidate appearing in +3 Final year Physics paper should be allowed to take a student as a scribe who is studying in +3 second year or below and must not be pursuing physics. For the B.Ed. Entrance, Graduate student will not be allowed as scribe. The scribe must be less than Graduation qualification. Proper identity of the scribe in this regard is required to be submitted at the examination centre.
- If the Scribe is provided by the Examination conducting body, the candidate should be allowed to meet him at least 2 days prior to commencement of the examination so that the candidate could familiarize with the scribe or could report to the examination center superintendent well in advance, if he / she is not satisfied with the scribe.
- All PH candidates shall be allowed to appear examination in the ground floor only.

#### 4.7 OOT Candidates :

- Candidates from the Outlying Odia speaking Tracts of Andhra Pradesh, Jharkhand, Chhatisgarh and West Bengal with required academic qualification / conditions as indicated above are eligible to apply.
- They are required to submit permanent Residential Certificate to that effect, issued in prescribed form in their favour by the competent authority of their respective state.
- **Only those candidates who have prosecuted their studies at least up to High School Certificate Examination in their respective states will be considered for selection under the Outlying Odia Speaking Tract quota.**
- They should have passed Odia as a subject of study in HSC examination or any such equivalent or higher examination or have passed Odia as a subject in single subject examination conducted by BSE, Odisha of HSC standard.
- **Kashmir Migrant:** The following type of relaxation will be admissible in case Kashmir Migrants in the matter of their admission (vide Government letter No. 6110 / SME dated 15.04.2010)
  - Extension in date of admission by about 30 days.
  - Relaxation in cut-off percentage up to 10% subject to minimum eligibility requirement.
  - Increase in intake capacity up to 5% - course - wise.
  - Reservation of at least one seat in merit quota in technical / professional institutions.
  - Waiving of domicile requirements
  - Facilitation of migration in second and subsequent years.

#### 4.8 Ex-servicemen Candidates :

- The person who is retired from Defence service (Army, Navy and Airforce) is to be considered as Ex-serviceman except Central Army Police Force (CAPF). The son / unmarried daughter / spouse of Ex-serviceman including self are eligible to apply on submission of **Certificate issued by the Rajya Sainik Board, Nageswar Tangi, Odisha, Bhubaneswar** in favour of his / her parents / spouse at the time of filling up of the Online Application Form. The certificate must reflect the name of ex-serviceman, the date of entry to the defence service and retirement, his relationship with the candidate, seal and signature of the concerned authority. **The Upper age limit relaxation for the Ex-serviceman self candidates shall be applicable as the State Government Rules.**

#### 4.9 Sportsperson Category Candidates :

- In case of Sportsperson Category, candidates **must have represented Odisha in National School Games organized by School Games Federation of India and representing Odisha / India in national / international championship organized by recognized National / International Federation in Senior / Junior / Youth category in the disciplines approved by Sports and Youth Services Department, Odisha.**
- The Director, Secondary Education, Odisha is to countersign the certificates issued by School Games Federation of India.
- The Director, Sports and Youth Services will issue weightage certificate in respect of Certificates issues by National / International Federation.
- The above conditions are approved vide Government Resolution No. 2859/SYS dated 21.11.2003.
- Certificate issued by any officer / organization other than the above conditions shall not be entertained.

**Additional Eligibility condition for Santali Quota (in addition to common eligibility conditions mentioned at Para 4.0) :**

- Those candidates who can read (with understanding) and write Santali language is only eligible to apply.
- The Candidates seeking admission in DIET, Mayurbhanja at Baripada for Santali D.El.Ed. Course shall have to appear the language Subject of Entrance Test in Santali Language compulsory.
- **The selected candidates on the basis of their Entrance mark shall be referred immediately to a Board constituted for verification of reading (with understanding) and writing ability in Santali language at DIET, Baripada. On the basis of the report of the Board, the admission shall**



be given only to the candidates suggested by it. The decision of the selection board is final.

**Additional Eligibility condition for Christian Community Quota (in addition to common eligibility conditions mentioned at Para 4.0) :**

- All the women candidates interested for admission to D.El.Ed. course in Thompson Women's Training School, Cuttack shall have to appear the general entrance test conducted by TE & SCERT.
- Out of 50 total number of seats, 25 seats will be reserved for the Christian minority community women candidates and Dalit Christian and rest 25 seats for other women candidates.
- Out of the total 25 number of minority seats, 13 seats will be filled up by the Christian minority candidates and 12 seats by the Dalit Christian. In case of non-availability of qualified candidates in any category there will be interchange of seats.
- Christian minority candidates shall produce the required documents and their caste certificate in support of their caste and other documents etc. as per the requirement at the time of admission in the Thompson women's training school, Cuttack.

### 6.0 Interchange of Seats :

**Total seats in each category shall be distributed between Arts / Commerce and Science discipline candidates on 50 : 50 basis.**

If the available seats in any category of Arts / Commerce and Science happens to be odd number, in such case benefit shall go to the candidates having the higher career marks either in Arts / Commerce and Science category.

- In case of non-availability of eligible candidates in any one PH category (VI, HI, Locomotor, as indicated at point No. 4.6) and OOT (Andhra Pradesh, West Bengal, Jharkhand, Chhatishgarh) Categories, the vacant seats will be filled up by the other PH and OOT category candidates respectively.
- Interchange of seats among the institutions keeping the total seat allotted to different categories intact shall be permitted.
- **The seats earmarked for special reserved candidates shall be converted and added to total number of seats for direct admission under Unreserved (UR) category if the specific categories of candidates are not available.**
- The candidates seeking admission under special reserved category can apply for any one.
- In no case SC / ST vacant seats shall be filled up by candidates from other categories.

### 7.0 Modalities of Online Computer Based Test :

**There will be Online Computer Based Test for selection of candidates.**

The whole test is of 1 and 1/2 hours (**90 minutes**) duration carrying **90 marks** with *two sections*.

**Section – I** carries 30 marks. There shall be 30 questions, each carrying one mark.

**Section – II** carries 60 marks. There shall be 60 questions each carrying one mark.

All the questions shall be of multiple choice type.

**The test will be bi-lingual for all the subjects except the language subject. Each Question in the language section shall be available to candidates in Odia, Urdu, Telugu and Santali.**

**Negative Marking :** The performance of the candidates shall be evaluated both on the basis of correct and incorrect responses. **For every incorrect response, 0.25 mark shall be deducted from the marks secured by the candidate for correct responses.**

**More than one response to a question shall be considered incorrect and negative mark will be awarded.**

**Venue of the Test :** The Online Computer Based Test shall be conducted in the Centres identified by the Examination conducting agency approved by Government.

**Issue of Admit Card :** Admit Cards shall be issued Online. The candidates are required to take print out of the same and produce at the Examination Centre. Candidates have to provide their identity proof at the time of Entrance Test.

**Time and Date of Online Computer Based Test : Will be communicated to the applicants through SMS / Mail and will be published in the Website**

## **SYLLABUS FOR ENTRANCE EXAMINATION**

Selection for admission to the D.El.Ed. Course (General, Urdu, Telugu & Santhali) shall be made through an Entrance Test.

The Online Computer Based Test shall have Two Sections.

The whole test is of 90 marks. Section – I carries 30 marks. There shall be 30 questions, each carrying one mark. Section I shall include four aspects, which have been detailed out.

Section II carries 60 marks. There shall be 60 questions each carrying one mark. All the questions shall be of multiple choice (MCQ)

**Instructions for the Candidates :**

- The candidates are required to take their seats in the Examination Hall 30 minutes before the commencement of the examination.
- The candidates are required to occupy the seats allotted to them. The candidates are not allowed to change their seats or examination halls.
- No candidate will be allowed to enter the Examination Centre and take examination after the commencement of the examination.

## **8.0 Selection and Placement :**

### **8.1 Publication of Final Result :**

The provisional scoring key shall be made available in the website for reference of the candidate. After 3 days of the completion of the entire Computer Based Test for all the courses. The online queries on the scoring key shall be invited for 3 days from the candidates. On the basis of the queries received from the candidates the Expert panel will analyzed the complains and if found genuine the final scoring key shall be made available within 1 week. The decision of the Expert Committee in case of any discrepancy, in the question paper as well as the scoring key shall be treated as final.

### **8.2 Selection Authority :**

State Level Selection List of all categories of candidates is to be published by the computer firm on the basis of Online Computer Based Test marks and shall be approved by the Directorate of TE and SCERT before admission.

### **8.3 Selection and Placement :**

State Level Selection of all categories of candidates shall be made through **Online Computer Based Test** on the basis of their marks secured in Entrance Test.

The result of the Entrance Test does not ensure the confirmation and guarantee of admitting the student to the Course as it is subject to verification of the authenticity and appropriateness of the documents.

Selection and placement of candidate shall be made purely on the basis of marks secured by him / her in the Online Computer Based Entrance Test. Merit list shall be published on the basis of the result of Entrance Test both category-wise and subject-wise. In case of tie, the higher percentage of marks at +2 levels shall be taken into consideration. If the +2 Mark becomes tie, in that case, the candidate who born earlier will come first in the Merit List.

Placement of candidates will be made centrally through **online placement** as per the choices given by the candidate. The original certificates and mark sheets of the selected candidates shall be verified at the institution

level, where the candidate will be placed for admission. If any discrepancies are observed, then the provisional selection of the candidate for admission will be cancelled.

***The transfer of the candidate shall be made only through the auto slide-up process subject to vacancy in the respective social category and subject category.***
