### Need for Wildlife Conservation efforts Projects in India

Wildlife was traditionally hunted in the past, which caused the population of many animals to decline.

It was decided in the 1989 case of State of Bihar v. Murad Ali Khan that hunting is against the Wildlife Protection Act, 1972. The Wildlife Protection Act of 1972's Section 2(16) provides a thorough definition of hunting. In this instance, it was claimed that the defendants had shot and killed an elephant in the Kundurugutu Range Forest. The elephant's ivory tusks were also removed. The Forest Range Officer then filed a complaint in accordance with Section 51 of the Wildlife Act.

The aforementioned example demonstrates that despite laws, people proceeded with destructive actions. As a result, there was a need for conservation projects, and India established numerous of them.

We need conservation projects:

- 1. To conserve wildlife;
- 2. To conserve habitats;

- 6. To assist eco-tourism;
- 7. To protect ecological stability;

- 10. To preserve heritage and culture; and
- 11. To protect livelihood and knowledge of indigenous tribes.

The need to safeguard these animals from poaching and killing cannot be overstated. This is so because each species is essential to maintaining the diversity and health of the environment. Wildlife will drastically decrease if drastic action is not done. They will eventually become extinct as a result of this. The symbiotic ties between various species are the only thing that matter in an ecosystem.
