Note 2. The Register number of candidates who have secured **top most** Mark in the OMR test (Common Preliminary Exam Degree Level) are included in the list.

Note 3. The candidates who have secured **1.2071 (one (point) two zero seven one)** Marks and above after standardisation in preliminary OMR test are included in the eligibility list.

Note 4. The marks secured in the Common Preliminary Examination Degree level by the candidate will be considered only for ascertaining the eligibility to appear for the final exam and will not be considered for the purpose of final ranking and shall not have any relevance while preparing the Rank List for the post.

Note 5. If any of the documents produced by any candidate is found defective the Commission reserves the right for rejection of their candidature at any stage of selection as per rule.

Note 6. According to the existing procedure, revaluation of Answer Script is not allowed. But answer scripts will be rechecked if the candidates apply only through their One Time Registration profile from the Commission's official Website www.keralapsc.gov.in by remitting the prescribed fee of Rs. 85/- (Rupees Eighty Five Only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. A period of 15 (Fifteen) days to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which the Eligibility list is uploaded in the website of the Commission. The candidates can avail only one chance after the approval of Eligibility List. Rechecking of invalidated answer scripts due to any defects will not be considered. Fee once remitted will not be refunded. Applications submitted through email/by post/in person will not be considered.

Note 7: Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the official website of the commission www.keralapsc.gov.in by remitting the prescribed fee of Rs.335/- Rupees Three Hundred and Thirty Five only) via e-payment mode available in the portal. A period of 15 (Fifteen) days to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Eligibility list uploaded in the website of the Commission. A copy of an answer sheet will be issued to a candidate only once. Copies of OMR answer sheets invalidated due to any defect will not be issued. Applications submitted through email/by post/in person will not be considered.
