RECRUITMENT TO 200 POSTS OF AGRICULTURE DEVELOPMENT OFFICERS (GROUP-A) IN THE DEPARTMENT OF AGRICULTURE & FARMER WELFARE, GOVT. OF PUNJAB

1. It is for the information of the candidates who had appeared in the written competitive examination held on 30/06/2024, for recruitment to these posts, the candidates mentioned in Annexure-A have been **provisionally shortlisted** for the scrutiny of the documents.
2. The provisionally shortlisted candidates mentioned in Annexure-A are in the order of respective roll numbers and **NOT as per written competitive exam merit.**
3. As per the proviso **8.6** of "General Information for the Candidates", the **provisionally shortlisted candidates** are directed to submit their hard copy of online application form along with self-attested copies of all the eligibility documents in person in the office of Punjab Public Service Commission, Patiala as per schedule mentioned in Annexure-A.
4. The Candidates **MUST** bring the following Self Attested Certificates/Documents along with signed copy of the printout of online application form:-
 - i) Proof of Date of Birth: Certificate of Matriculation/Higher Secondary
 - ii) Proof of having passed Punjabi language
 - iii) Relevant Degree and DMC Certificate
 - iv) Sports Gradation Certificate issued by the competent Authority (if applicable)
 - v) Persons with Disability Certificate issued by the competent Authority (if applicable).
 - vi) Reserve Category Certificate issued by the competent authority (if applicable)
 - vii) Latest Punjab Residence certificate (for all Reserve Categories including Female, EWS candidates who have applied in General Category) issued by the competent authority..
 - viii) Experience certificate issued by competent authority (if applicable)
 - ix) ESM Certificates/Documents mentioning the following (if applicable):
 - a) Date of Enrolment
 - b) Date of Release/Discharge
 - d) Reason of Release/ Discharge&
For LDESM candidates, produce **original LDESM certificate** (if applicable)

- x) Certificate as proof of age relaxation claim (if applicable)
 - xi) Certificate as proof of fee concession (if applicable)
 - xii) Proof of being a government employee (if applicable)
 - xiii) Any other certificate (if applicable)
 - xiv) Copy of Admit Card
5. Candidates are also required to bring **Original Certificate/Documents** at the time of submission of the documents copies for scrutiny.
 6. The application forms and requisite documents of provisionally shortlisted candidates shall be scrutinized by the Commission. During the scrutiny of the application forms, if any provisionally shortlisted candidate is found to be ineligible, then his/her candidature shall be cancelled by the Commission.
 7. While every care has been taken in preparing and uploading the list of shortlisted candidates for the scrutiny of the documents, possibility of inadvertent/technical errors cannot be ruled out. The Commission reserves the right to rectify the same at any stage.
