TERMS AND CONDITIONS:

1. Reservation shall be as per Karnataka State Government norms.
2. Age limit shall be as per Cadre & Recruitment Rules of BMCRI, Bengaluru.
3. The appointments shall be on contractual basis on monthly consolidated remuneration.
4. Appointments shall be bound by NMC norms, Bye-laws and C&R Rules of BMCRI, Bengaluru.
5. Statutory deductions EPF & ESI are not applicable.
6. Candidates working in Government Sector/ Government Autonomous Medical Colleges must submit "NOC" from the Head of the Institute in which the candidate is presently working.
7. Candidates should submit application in the prescribed format.
8. Candidates should produce all original Marks cards & other related original documents at the time of interview.
9. TA DA will not be paid to the candidates.
10. Applications submitted after **15.04.2025 (TUESDAY)** – 5:30 PM on will not be considered.

ELIGIBILITY CRITERIA

1. Qualification:

Post	Qualification
Nursing Officer	Must be a holder of degree in Nursing (B.Sc) or Diploma in Nursing & Must be registered in Karnataka Nursing Council

2. Classification of Reservation for the Posts- as per

- a. Government Notification No: DPAR 06 LX 2012, Bengaluru, dated: 06.11.2013.
- b. ಸರ್ಕಾರದ ಆದೇಶ ಸಂಖ್ಯೆ: ಸಿಆಸುಇ 01 ಸೇನಿಸೇ 2022, ಬೆಂಗಳೂರು, ದಿನಾಂಕ: 28.02.2022.

3. Certificate for Caste Reservation:

Candidates claiming reservation shall produce caste certificates i.e., SC/ ST in Form No D, Cat-I in Form No E, Cat-IIA, IIB, IIIA, IIIB in Form No F and shall be valid as per rules.

4. Rural Candidate:

- a. The Candidates who have studied and passed from 1st Std to 10th Std in the rural areas specified in the existing rules are eligible for claiming for rural reservation. They shall produce a valid Rural Reservation Certificate issued by BEO, necessarily countersigned by DDPI of the concerned jurisdiction, in the prescribed Form No 2 as per Govt. Order No dated: 10.08.2025.
- b. The Candidates belonging to SC/ST, Cat-I, Cat-IIA, IIB, IIIA, IIIB shall produce Rural Reservation Certificate in Form No. 2.
- c. The Candidates belonging to General Merit shall produce rural reservation certificate in Form No 2 along with Form 1 certificate.
- d. If the Rural Reservation Certificate produced by the candidates belonging to SC/ ST, Cat-I, Cat-IIA, IIB, IIIA, IIIB is rejected, then they shall become ineligible for Rural Reservation.

5. Persons with disability & Ex-Servicemen:

The Candidate shall produce certificate of disability from the appropriate authority as per rules.

6. The candidates who are blacklisted by KNC and those with any pending criminal cases/ Debarred candidates/ candidates dismissed from service shall not be eligible.

7. Reservation for Kalyana Karnataka Region local persons:

The candidates belonging to Kalyana Karnataka region shall be regarded as local persons if he/ she produces eligibility certificate issued by Jurisdictional Assistant Commissioner, Revenue Sub Division as specified in the Govt. Order No. DPAR 43 HKC 2013, dated: 29.01.2014.

8. Selection Committee has got full powers to decrease/ increase the number of posts.

9. Misconduct:

A candidate found guilty of impersonation or submitting fabricated documents OR documents which have been tampered with OR making statements which are incorrect OR false OR of suppressing material information OR of using OR attempting to use unfair means for purpose of recruitment OR otherwise resorting to any other irregular OR improper means in connection with his recruitment, may in addition to rendering him/ herself liable to Criminal prosecution & Disciplinary action, also be debarred wither permanently OR for a specified period.
