- A Post Graduate qualification MD (Biochemistry) / MSc (Medical Biochemistry) with PhD in Medical Biochemistry for Biochemistry Department.
- A Post Graduate qualification MD (Physiology) / MSc (Medical Physiology) with PhD in Medical Physiology for Physiology Department.

Candidates having DM/ M.Ch./ DNB in the concerned super specialty subject will be given preference/ weightage

- 7. Weightage shall be given to the Doctors working under Rule 17A of MHRB Regulations or any contractual engagement under any health care institute under the Medical Education & Research Department including post P.G. contractual engagement.
- 8. Willing and eligible doctors serving under the Directorate of Medical Education (DME)/ Directorate of Health Services (DHS) / National Health Mission (NHM), Assam and other Govt. Agencies will be eligible to apply and no separate NOC from the State Govt. will be required to apply for these posts.
- Process of Recruitment: The selection procedure will be notified later on by issuing Notice. The Board will decide the procedure for selection in respect of the posts on the basis of the number of applications received.
- 10. <u>Application fees:</u> Application must be accompanied with required application fee of Rs. 250/-(rupees two hundred fifty) only for General category candidates and Rs. 150/- (rupees one hundred fifty) only for OBC/MOBC/SC/ST (P)/ST (H) candidate. No application fee is required for candidates having PWD certificate. Application fee may be deposited, through Treasury Challan in the Head of Account "0210-Medical and Public Health-01-Urban Health Services-800-Other Receipt".

Candidates may pay the requisites fees (as admissible for the category mentioned above). Printed copy of Treasury Challan generated through GRAS should be submitted at the time of interview. In Remarks column, candidate may write the post applied for.

11. Process to Apply:

b) Candidates must use their mobile number and password to login.

c) After that, candidates can fill up the form for that given post.
