Cor In exercise of the powers conferred by Rule 6 of the Tripura Civil Service Rules, 1967, and Rule 6 of the Tripura Police Service Rules, 1967, the Governor in consultation with the Tripura Public Service Commission hereby makes the following Regulations to further amend the "Tripura Civil Service and Tripura Police Service (Appointment by Combined Competitive Examination) Regulations, 1975":-

#### 1. Short Title & Commencement.

- (i) These regulations may be called the "Tripura Civil Service and Tripura Police Combined (Appointment by Competitive 14th (Fourteenth Amendment) Regulations, 2017";
- (ii) They shall come into force from the date of their publication in the Official Gazette.

#### Amendment of Regulation 12 of Part-II:-2,

The subjects/papers of Regulation 12 of the "Tripura Civil Service and Tripura Police Service (Appointment by Combined Competitive Examination) Regulations, 1975 shall be substituted with the following subjects/papers:-
