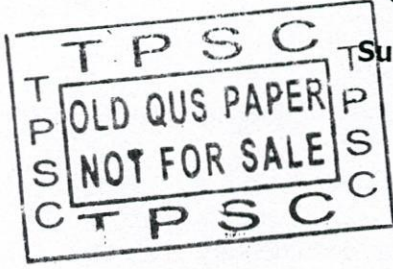

- iii. In presence of an Executive Magistrate within his local jurisdiction an offence is committed by A. Whether the Executive Magistrate himself can arrest or order the arrest of A and commit him to custody?
- iv. The Officer-in-Charge of a Police Station received information that a person has committed suicide. Immediately after that he proceeded to the place of occurrence for making investigation without sending any intimation to the Executive Magistrate. Has the police officer committed any breach of law?
- v. Is an Arbitrator, appointed by the Chief Justice of the High Court for determination of disputes as per provisions of the Arbitration and Conciliation Act, 1996, a Public Servant?
- vi. X, a boy of aged 6 years 6 months, steals an article from possession of Y, a shop keeper. Can X be prosecuted for committing the offence of theft?

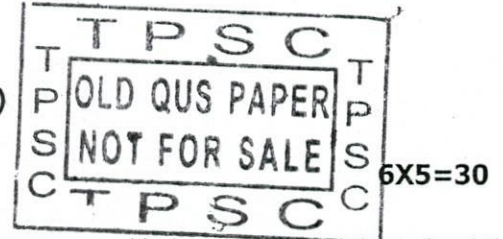




- vii. Is the possession of a clerk, temporarily appointed, can be considered as possession of the employer within the meaning of the Indian Penal Code?
