Agriculture Service (PC.No.03) - vide Notification No:19/2021, dated 16/11/2021. The candidates provisionally admitted for verification of certificates are required to produce the Original Certificates at the time of verification of documents, relating to **Age (SSC), proof of age relaxation, Educational Qualification, Study Certificates, Migration certificate for candidates who migrated from Telangana to Andhra Pradesh, Integrated Community Certificate in case of reserved candidates, Non-creamy layer certificate in case of B.Cs from Revenue Authorities (As per G.O. Ms. No.3, Backward Classes Welfare (C-2) Department, Dt:04-04-2006 and G.O.Ms.No.26, BC Welfare (C) Dept., Dt: 09-12-2013) who claim reservation under BC Community and Sports Category certificate etc.**, failing which, they will not be treated as eligible with reference to the particulars furnished by him/her in the Online Application Form / Certificates. The candidature of such candidate(s) shall be cancelled at any stage in the process of selection. The Commission has the right to disqualify any candidate, if he/she is not found eligible for any reason.
