Martyrs' Day



Context:

- In India, March 23rd is commemorated as Martyrs' Day, also known as Shaheed Diwas.
- This day specifically honors the sacrifices of three legendary freedom fighters: Bhagat Singh, Sukhdev Thapar, and Shivaram Rajguru.

About:

- These three revolutionaries were hanged by the British Raj in 1931 for their role in resisting British rule.

Note:

- January 30th is also celebrated as Martyr's day.

NTPC mulls offering power from TSTPP phase II

Context:

- The National Thermal Power Corporation (NTPC) is considering offering power generated from the upcoming Phase II of the Telangana Super Thermal Power Project (TSTPP) to other states.
- This comes as the **Telangana government has yet** to sign a power purchase agreement (PPA) with NTPC, a crucial step for the project's execution.
- NTPC warns that if the agreement isn't signed by Telangana, they will be forced to offer the 2,400 MW of power to other states in the southern reaion.
- This could leave Telangana facing a power shortage despite the project being located within the state.

Hyderabad Metro Rail using Al, IoT for maintenance: MD

Context:

- Hyderabad Metro Rail (HMR) is leveraging cutting-edge technology for efficient maintenance.
- They've adopted both Artificial Intelligence (AI) and Internet of Things (IoT) to achieve "predictive maintenance."
- This approach aims to anticipate and address potential issues before they disrupt service, ultimately reducing costs.









- Together, they outplayed the Maharashtra-Delhi pair of Vishwa Tambe and Nathania Jain (11-6, 9-11, 11-8, 11-6).
