<p><b>Standardised Precipitation Index</b></p>	<p><b>Why in the news?</b></p> <ul style="list-style-type: none"> <li>● The <b>India Meteorological Department</b> recently used the '<b>Standardised Precipitation Index</b>' (<b>SPI</b>) to <b>analyze trends in precipitation and drought-like conditions over India</b>.</li> </ul> <p><b>About Standardised Precipitation Index:</b></p> <ul style="list-style-type: none"> <li>● <b>Purpose:</b> <b>Estimates wet or dry conditions</b> based on <b>precipitation variables</b>.</li> <li>● <b>Calculation Basis:</b> <ul style="list-style-type: none"> <li>○ Based on long-term precipitation record for a specific location.</li> <li>○ Requires a long-term period (preferably longer than 30 years).</li> </ul> </li> <li>● <b>Index Nature:</b> <ul style="list-style-type: none"> <li>○ <b>Negative</b> for <b>drought</b> conditions.</li> <li>○ <b>Positive</b> for <b>wet conditions</b>.</li> <li>○ <b>Becomes more negative or positive</b> with <b>increasing severity of dry or wet conditions</b>.</li> <li>○ <b>Time Scales:</b> Includes timescales of 1, 2, 3, 6, 9, 12, 24, 36, 48, 60, and 72 months.</li> </ul> </li> </ul>

- The **Union Minister of Cooperation** recently informed the Rajya Sabha about **Bhartiya Beej Sahkari Samiti Limited (BSSSL)**.

### About BSSSL:

- **Establishment:** Set up under the **Multi-State Cooperative Societies (MSCS) Act, 2002**.
- **Promoters:** IFFCO, KRIBHCO, NAFED, National Dairy Development Board (NDDB), and NCDC.
- **Functions:**
  - **Production, procurement, and distribution of quality seeds** under a single brand via cooperatives.
  - **Improve crop yield and promote indigenous natural seeds.**
  - **Increase seed replacement rate** and varietal replacement rate.
  - Ensure farmer involvement in the **production of certified seeds**.
  - Focus on production, testing, certification, procurement, processing, storage, branding, labeling, and packaging of foundation and certified seeds.
  - **Nodal Agency:** Ministry of Cooperation.
