Israel versus the UN

Context: Israel has banned UN Secretary-General António Guterres from entering its country in the backdrop of his criticisms of Israel's action in Gaza war.

What actions has Israel taken against the UN system?

- Israel has deliberately targeted the UNRWA, an organisation India supports, accusing the UN agency of Hamas links.
- Israeli PM Netanyahu referred to the UN as an "anti-semitic" swamp
- Israeli forces launched attacks on the UN peacekeeping force in Lebanon (UNIFIL), where 903 Indian soldiers are deployed as a part of a 50-nation, 10,000 strong force.
- Banned UN Secretary-General António Guterres from entering Israel

Why is India's position on this matter significant?

- India didn't join other countries in publicly backing the UN leader and disapproving of Israel's actions against him.
- India is a leading member of the UN system and has made significant contributions
- India's stance is seen as an exercise of 'realpolitik' restraint
- India has close bilateral ties with Israel

What is the article's stance on India's position?

- Expresses disappointment that India kept itself at arm's length from statements critical of Israeli actions against the UN
- Argues that when it comes to the importance of UN-based international rule of law and global order, there can be no half-measures
- Suggests that India should have taken a stronger stance in support of the UN system

A perilous highway to salvation in the Himalayas

Context: The environmental and social impacts of the Char Dham Highway Project in Uttarakhand

What are the main environmental concerns associated with the Char Dham Highway Project?

- Increased landslides: The study identified 309 road-blocking landslides along the 247 km stretch
- Road-widening has doubled the impact on road-blocking landslides
- Predicted increase in summer monsoon precipitation due to climate change, leading to more frequent extreme rainfall events and landslides
- Destabilization of the entire region due to massive construction activities
- Ground subsidence in many parts of the Himalayas

How has the project been implemented, and what are the criticisms?

- The project was divided into 50-plus smaller projects to bypass environmental clearance and impact assessment reports
- It violates environmental norms and conservation strategies for the Himalayas
- Initially presented as a tourism project, later defended as a defense-related requirement
- Implemented without proper scientific assessment in an unstable and fragile region

What are the socio-economic impacts of such large-scale projects in Uttarakhand?

- Depopulation and land abandonment in rural areas
- Shift from agriculture to tourism-related employment
- Local people selling land to private entrepreneurs from the plains
- Increased unemployment and migration

What solutions does the article suggest?

- Scale down ongoing massive construction programs, including dams
- Formulate sound ecological solutions for the existing environmental issues
- Respect important environmental caveats before commencing large engineering projects in the Himalayas
- Follow the government's original policy framework recommending "best practice" norms for infrastructural expansion in mountainous regions
