<p><b>Marek's disease (MD)</b></p>	<p><b>Why in news?</b></p> <ul style="list-style-type: none"> <li>• Biopharmaceutical company Boehringer Ingelheim has launched a next generation poultry vaccine for Marek's disease in the country.</li> </ul> <p><b>Key Points:</b></p> <ul style="list-style-type: none"> <li>• Marek's disease (MD) is a <b>highly contagious viral disease that affects chickens and other gallinaceous birds.</b></li> <li>• <b>Symptoms:</b> MD causes lymphoma in the nerves, paralysis, tumors, enlarged follicles, and high mortality.</li> <li>• <b>Transmission:</b> Birds inhale contaminated dust from poultry houses, and the virus is shed from the feather follicles of infected birds.</li> <li>• <b>Treatment:</b> There is no treatment for MD.</li> </ul>
<p><b>Kaleshwaram lift irrigation project</b></p>	<p><b>Why in news?</b></p> <ul style="list-style-type: none"> <li>• The PC Ghose Commission cross-examined 18 assistant executive engineers (AEEs) and deputy executive engineers (DyEEs), who worked at lower level during the construction of Medigadda barrage of Kaleshwaram Lift Irrigation Scheme.</li> </ul> <p><b>Key Points:</b></p> <ul style="list-style-type: none"> <li>• <b>Location:</b> KLIP is a multipurpose irrigation project on the Godavari River i.e, at Kaleshwaram village in Telangana.</li> <li>• The <b>Pranhita-Godavari river confluence is the location of KLIP.</b></li> <li>• The <b>Wardha, Painganga, and Wainganga rivers, which together make up the seventh-largest drainage basin</b> on the subcontinent, come together at the confluence of the Pranahita River.</li> <li>• It is claimed to be the <b>world's largest multi-stage and multi-purpose lift irrigation project.</b></li> </ul>

<p><b>National Green Tribunal (NGT)</b></p>	<p><b>Why in news?</b></p> <ul style="list-style-type: none"> <li>● The Union ministry of environment and forest has submitted a report to the National Green Tribunal, asserting that both the state irrigation department and Telangana Tourism Development Corporation have encroached upon the Manair riverbed during the construction of the riverfront project in Karimnagar.</li> </ul> <p><b>Key Points:</b></p> <ul style="list-style-type: none"> <li>● NGT has been established under the <b>National Green Tribunal Act 2010</b> for effective and expeditious disposal of cases relating to environmental protection and conservation of forests and other natural resources.</li> <li>● <b>New Delhi is the principal place of sitting of the tribunal</b> and Bhopal, Pune, Kolkata, and Chennai shall be the other four places of sitting of the tribunal.</li> <li>● <b>Powers:</b> The NGT has the power to hear all civil cases relating to environmental issues and questions that are linked to the implementation of laws listed in Schedule I of the NGT Act.</li> <li>● NGT has <b>appellate jurisdiction to hear appeals as a Court.</b></li> </ul>
