1. The candidate can look at the Question Id from the Question Paper Response which is available in the "Question Paper" tab. Candidate should ensure that the Question Id is as per the Question Paper Response only.
2. After the candidate has filled all the required fields such as Section Name, Question Id etc., (s)he should click on "Pay & Submit" button to complete the payment process and submit the objection successfully.
3. Applicable fee is Rs. 200\* per objection. This fee does not include transaction Processing Fee and applicable charges (if any).
4. Only one objection can be submitted at a time. In case candidate wants to raise Multiple Objections, he can click on "+" in the Objection list and raise multiple objections. All the submitted objections (After Successful Payment) will be available in the Objection list in the "Objection Form" Tab under "Your Selection".
5. Click on "Click to Refresh" button to see objections raised by you in "Your Selection" page
6. Objections once submitted cannot be edited later.
7. Once an objection is raised for any question, fee will not be refunded. If you want to raise new objection against same question, you must pay again.
8. Mode of payment will be online only. No other payment mode will be accepted.
9. Ambiguous Objection/Incorrect Option ID will not be considered.
10. Response of the concerned examination authority will be treated as final against the objections raised. In case this process leads to any change in the evaluation mechanism, the decision taken by the concerned authority will be treated as final.
